MOTOR CAR (INTERNATIONAL CIRCULATION) AMENDMENT ORDER, 1921.

Notice is hereby given that in pursuance of the powers conferred upon him by the abovementioned Acts and Order the Minister of Transport has made regulations to come into operation on the first day of March, one thousand nine hundred and thirty, providing for the total or partial exemption for a limited period from the duty payable under Section 13 of the Finance Act, 1920, as amended by subsequent enactments, of vehicles brought into Great Britain otherwise than from Northern Ireland by persons making only a temporary stay in Great Britain, and for making provision for the registration and identification of such vehicles, and for the issue of licences to drive such vehicles.
