1. This Order may be cited as the Wandsworth Registration of Births, etc., Order, 1930, and shall come into operation on the 1st day of April, 1930.

2. The existing Sub-districts of East Battersea, North West Battersea and South West Battersea of Wandsworth Registration District shall cease to form part of that Registration District and shall together comprise a new Registration District co-terminous with the Metropolitan Borough of Battersea which shall be known as Battersea Registration District.

3. The existing Sub-districts of Clapham, Streatham, Tooting, Balham, Springfield, Southfields and Putney of Wandsworth Registration District shall together comprise that Registration District co-terminous with the Wandsworth Metropolitan Borough.

#### URBAN DISTRICT OF SHOREHAM-BY-SEA.

**B**Y an Order dated the 9th day of January, 1930, made under Section 77 of the Public Health Act, 1925, the Minister of Health has extended until the 22nd day of August, 1931, the operation of the Shoreham-by-Sea Private Street Works Order, 1927, which prescribed the rate of interest recoverable by the Council of the Urban District of Shoreham-by-Sea in respect of expenses for private street works incurred by the Council at 5½ per cent. per annum instead of the rate of 5 per cent. per annum prescribed by Section 77.

#### ELECTRICITY (SUPPLY) ACTS, 1882 TO 1928.

HYTHE (HANTS) ELECTRICITY SPECIAL ORDER,  
1930.

**N**OTICE is hereby given that the Electricity Commissioners have submitted to the Minister of Transport for confirmation under the above-mentioned Acts a Special Order made by them to be granted to the General Estates Company Limited for the supply of electricity within part of the Parish of Dibden in the Rural District of New Forest in the County of Southampton.

The Minister of Transport proposes to confirm the Order and gives notice that any person affected who may be desirous of objecting to the confirmation of the same must, in accordance with the Electricity (Confirmation of Special Orders) Rules, 1921, do so by memorial addressed to the Minister of Transport written on one side only of foolscap paper and sent by registered post addressed to The Secretary, Ministry of Transport, 6, Whitehall Gardens, London, S.W. 1, and posted not later than the 12th day of February, 1930.
