ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

BIRKENHEAD IMPORTED ANIMALS WHARF ORDER OF 1930.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Definition of Imported Animals Wharf.

1.—(1) Such part of the premises described in the First Schedule hereto as is not, for the time being, included within the limits of a

Landing Place approved by the Minister for the purposes of the Animals (Landing from Ireland, Channel Islands and Isle of Man) Order of 1923 and the Importation of Canadian Cattle Order of 1923, is hereby defined as an Imported Animals Wharf for the purposes of the Diseases of Animals Acts, 1894 to 1927, and any Order of the Minister thereunder.

(2) The Minister may approve for use as a Landing Place for the purposes of the Animals (Landing from Ireland, Channel Islands and Isle of Man) Order of 1923 and the Importation of Canadian Cattle Order of 1923, the whole of the premises described in the First Schedule hereto, or such part of the premises as is described in the Second or Third Schedule hereto, or any other part, as the case may be.

Commencement.

2. This Order shall come into operation on the twenty-seventh day of January, nineteen hundred and thirty.

Short Title.

3. This Order may be cited as the BIRKENHEAD IMPORTED ANIMALS WHARF ORDER OF 1930.
