

## TRADE BOARDS ACTS, 1909 AND 1918.

TOY MANUFACTURING TRADE BOARD  
(GREAT BRITAIN).PROPOSAL TO FIX PIECE-WORK BASIS TIME-RATES  
FOR ALL MALE AND FEMALE WORKERS.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 21st April, 1927, the Trade Board established under the Trade Boards Acts, 1909 and 1918, in Great Britain for the Toy Manufacturing Trade as specified in the Appendix to the Trade Boards (Toy Manufacturing Trade, Great Britain) (Constitution and Proceedings) Regulations, 1926, hereby give notice that they propose to fix Piece-work Basis Time-rates for all Male and Female Workers in the trade which shall be 10 per cent. above the appropriate General Minimum Time-rates for each class of workers set out in the Trade Board's Notice Y. (10), dated 6th September, 1929.

Pursuant to Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any Objections to the above Proposal to Fix which may be lodged with them within two months from the 31st January, 1930. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary, Toy Manufacturing Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W. 1.

It is desirable that Objections should state precisely and, so far as is possible, with reasons, what is objected to.
