"And whereas the District Chapelries and the Districts named in the foregoing Table have become New Parishes of the character contemplated by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, by the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, and by the above mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said New Parishes should be altered in the manner which is hereinafter mentioned:

"Now, therefore, with the consent of the Right Honourable and Most Reverend Cosmo Gordon, Archbishop of Canterbury (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any as-surance in the law other than such duly gazetted Order, the boundaries of the said New Parish of Saint Mark, South Norwood, of the said New Parish of the Holy Trinity, Croydon, of the said New Parish of Saint Saviour, Croydon, of the said New Parish of Saint Paul, Thornton Heath, of the said New Parish of Saint John the Evangelist, Upper Norwood, of the said New Parish of Saint Stephen, Norbury, and of the said New Parish of Saint Alban, South Norwood, shall be altered so that (first) all those portions of the said New Parish of Saint John the Evangelist, Upper Norwood, and of the said New Parish of the Holy Trinity, Croydon, which are described in the First Schedule hereunder delineated written and are and set forth upon the map or plan hereunto annexed and are thereon coloured pink shall be dissevered from such New Parishes and shall be annexed to and shall in future form part of the said New Parish of Saint Mark, South Norwood; (secondly) all that portion of the said New Parish of Saint Mark, South Norwood, which is described in the Second Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured purple shall be dissevered from such New Parish and shall be annexed to and shall in future form part of the said New Parish of Saint John the Evangelist, Upper Norwood: (thirdly) all that portion of the said New Parish of Saint Alban, South Norwood, which is described in the Third Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured yellow shall be dissevered from such New Parish and shall be annexed to and shall in future form part of the said New Parish of the Holy Trinity, Croydon; (fourthly) all those portions of the said New Parish of Saint Paul, Thornton Heath, and of the said New Parish of Saint Alban, South Norwood, which are described in the Fourth Schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon coloured blue shall be dissevered from such New Parishes and shall be annexed to and shall in future

form part of the said New Parish of Saint Saviour, Croydon; (fifthly) all those portions of the said New Parish of Saint Paul, Thornton Heath, and of the said New Parish of Saint Saviour, Croydon, which are described in the Fifth Schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon coloured green shall be dissevered from such New Parishes and shall be annexed to and shall in future form part of the said New Parish of Saint Alban, South Norwood; and (sixthly) all that portion of the said New Parish of Saint Stephen, Norbury, which is described in the Sixth Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured brown shall be dissevered from such New Parish and shall be annexed to and shall in future form part of the said New Parish of Saint Paul, Thornton Heath.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULES to which the foregoing Scheme or Representation has reference.

"The First Schedule.

"The territory to be annexed to the New Parish of Saint Mark, South Norwood, in the County of Surrey and in the Diocese of Canterbury, being :---

" I. All that portion of the New Parish of Saint John the Evangelist, Upper Norwood, in the said County and Diocese, which is bounded upon the south west, upon the south east and upon the east by the said New Parish of Saint Mark, South Norwood, and upon the remaining sides, that is to say, upon the north east and upon the north west, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Mark, South Norwood, from the said New Parish of Saint John the Evangelist, Upper Norwood, at the junction of Crescent Road with Lan-caster Road, and extending thence north westward along the middle of Lan-caster Road for a distance of 22 chains or thereabouts to its junction with the road called Woodvale Avenue, and extending thence along \mathbf{south} westward \mathbf{the} middle of Woodvale Avenue for a distance of 15¹/₂ chains or thereabouts to its junction with the road called South Norwood Hill upon the boundary which divides the said New Parish of Saint John the Evangelist, Upper Norwood, from the said New Parish of Saint Mark, South Norwood.

"II. And also all that portion of the New Parish of the Holy Trinity, Croydon, in the said County and Diocese, which is bounded upon the south east and upon the north east by the said New Parish of Saint Mark, South Norwood, and upon the remaining sides, that is to say, upon the north west and upon the south, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Mark, South Norwood, from the said New Parish of the Holy Trinity,
