(5) An Order entitled the North Western Casual Poor Assistance Authority Order, 1930, for combining the Administrative Counties of Lancashire and Cumberland, and the County Boroughs of Blackburn, Blackpool, Bolton, Bootle, Burnley, Bury, Carlisle, Liverpool, Manchester, Oldham, Preston, Rochdale, St. Helens, Salford, Warrington, and Wigan, for the purpose of the better administration of the relief of casual poor persons within the combined areas.
