

particular in regard to the following matters:—

As to construction and placing of pipes and fittings, as to mode of cutting off supplies, expenses of reconnecting discontinued supply, antifluators to be used with gas engines, period of error in defective meters, power to enter premises to which a supply of gas is laid on, charges for special reading of meters, provision of valve where high-pressure air or other gas is used, relief from obligation to supply in certain cases, to enable the Company to contract for the supply and purchase of gas in bulk, to enable several sums of money due by one person to be recovered by one summons or warrant, to make provision in regard to the authentication and service of notices by the Company and as to the recovery of demands and penalties.

The Order will vary or extinguish all rights and privileges which would impede or interfere with its purposes and confer other rights and privileges.

To repeal, alter or amend all or any of the provisions of the Heathfield and Waldron Gas Order 1915 and any other Act or Order relating to the undertaking.

To incorporate with the Order, with or without modification, or to render inapplicable all, or some of the provisions of the Gasworks Clauses Act 1847, the Gasworks Clauses Act 1871, and the Lands Clauses Acts.

Any local or other public authority, company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W. 1, and despatched on or before the 16th day of June 1930.

Any objection shall state:—

- (a) The specific grounds of objection; and
- (b) The omissions, additions or modifications asked for.

A copy of the objection must at the same time be forwarded to the undermentioned Parliamentary Agents.

A copy of the draft Special Order has been deposited with the Clerk of the Peace for the County of East Sussex at his office at the County Hall, Lewes, and at the Gasworks of the Company at Heathfield.

**WIGAN ELECTRICITY (EXTENSION) SPECIAL
ORDER, 1930.**

NOTICE is hereby given that the Electricity Commissioners have submitted to the Minister of Transport for confirmation under the above-mentioned Acts a Special Order

made by them for the supply by the Mayor, Aldermen and Burgesses of the borough of Wigan of electricity within the urban districts of Standish with Langtree and Upholland and part of the rural district of Wigan in the county palatine of Lancaster.
