##### BLACKPOOL IMPROVEMENT ACT, 1925.

#### REDCROSS STREET BURIAL GROUND (BRISTOL).

##### (ADDITIONAL PROVISION.)

**N**OTICE is hereby given that application is intended to be made to Parliament in the present Session by Veno Trust Limited (hereinafter called "the Company") by Petition for Additional Provision for leave to introduce into the Bill now pending in Parliament under the above name or short title provisions and amendments to give effect to all or some of the following objects and purposes (that is to say):—

1.
