Admiralty, dated the 7th day of May, 1930 (C.W. 3585/30), in the words following, viz.:—
"Whereas by Section 3 of the Naval and

Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased, by Section VI of Schedule V to Your Order in Council bearing date the 22nd day of January, 1920, to sanction, inter alia, the payment of an allowance of 1s. a day to non-Specialist Officers performing Specialist Duties when a qualified Specialist Officer is allowed by complement but not borne:

"And whereas we consider that this allowance should be paid under the same conditions to a non-Specialist Officer performing Physical and Recreational Training Duties when a qualified Physical and Recreational Training Specialist Officer is allowed by complement but not borne:

"We beg leave to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction this proposal, with effect from the 18th February, 1930.

" The  $\mathbf{Lords}$ Commissioners  $\mathbf{of}$ Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

· And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 8th day of May, 1930, in the words and figures following, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the

Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure of Presteigne with the Chapelry of Discoyd annexed (hereinafter called 'the said Benefice of Presteigne with Discoyd') in the Counties of Radnor and Hereford, and in the Diocese of Hereford:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Presteigne with Discoyd is vested for an estate in fee simple without incumbrances in Francis Reginald James, of Number 5, Saint Peter Street, Hereford, Solicitor:

"And whereas the said Francis Reginald James is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Presteigne with Discoyd, now vested in him as aforesaid, should be transferred to and be vested in the Bishop of Hereford for the time being:

"And whereas the Right Reverend Martin Linton, now Bishop of Hereford, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary, he, the said Martin Linton, Bishop of Hereford, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Presteigne with Discoyd which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Presteigne with the Chapelry of Discoyd annexed:

"Now, therefore, with the consent of the said Francis Reginald James (in testimony whereof he has signed and sealed this Scheme), and with the consent of the said Martin Linton, Bishop of Hereford (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Presteigne with Discoyd, now vested in him, the said Francis Reginald James, as aforesaid, shall be transferred to the said Martin Linton, Bishop of Hereford, and his successors in the said Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Martin Linton, Bishop of Hereford, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters afore-Act of the 31st and 32nd years of Her said late | said, or any of them, in accordance with the
