"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of Airedale with Fryston, comprising: --

"All those contiguous portions of the Parish of Ferry Fryston, of the District Parish of All Saints, Pontefract, and of the New Parish (sometime District) of Saint Paul, Glass Houghton, all in the County of York and in the Diocese of Wakefield, which, taken together, are bounded upon all sides as follows, that is to say, upon part of the west by the Parish of Castleford, in the said County and Diocese, upon the north by the Parish of Ledsham, in the said County of York and in the Diocese of York, and upon the remaining sides, that is to say, upon the east, upon the south, and upon the remaining part of the west, by an imaginary line commencing upon the boundary which divides the said Parish of Ledsham from the said Parish of Ferry Fryston at the centre of the bridge which carries the York and Normanton Line of the London and North Eastern Railway across the River Aire, and extending thence westward along the middle of the said line of railway for a distance of 18 chains or thereabouts to a point opposite to the northern end of the fence forming the eastern boundary of the close numbered 169 upon the Ordnance Survey Map of the Civil Parish of Ferry Fryston published in the year 1908 on the scale of 25 inches to a mile and also upon the map or plan which is annexed to this Scheme, and extending thence first southward to and then south westward along such fence for a distance in all of 10 chains or thereabouts to the point where is reaches the northern side of Wheldale Lane, and extending thence first southward to and then westward along the middle of Wheldale Lane for a distance in all of 1½ chains or thereabouts to a point opposite to the northern end of the fence forming the eastern boundary of the close numbered 143 upon the said maps, and extending thence first southward to and then first southward and then in various directions along such fence and along the fences forming the eastern and southern boundaries of the closes numbered 139, 117 and 112, upon the said maps for a distance in all of 61 chains or thereabouts to the south eastern corner of the last mentioned close, and extending thence southward in a straight line (thereby crossing Park Plantation) for a distance of 142 chains or thereabouts to the north eastern corner of the close numbered 66 upon the said maps, and extending thence first south eastward and then in various directions along the fences forming the eastern and south eastern boundaries of the said close numbered 66, and of the closes numbered 63, 62 and 61, upon the said maps for a distance of 67 chains or thereabouts to the point where the fence forming the eastern boundary of the said close numbered 61 reaches the north western side of Sheep Walk Lane, and extending thence first south eastward to

and then south westward along the middle of Sheep Walk Lane for a distance of 22 chains or thereabouts to a point opposite to the northern end of the fence forming the eastern boundary of the close numbered 51 upon the said maps and extending thence south eastward to and along the last mentioned fence for a distance of 23 chains or thereabouts to the point where it crosses the middle of the stream called Fryston Beck, and extending thence first south westward and then westward along the middle of Fryston Beck (thereby crossing the boundary which divides the said Parish of Ferry Fryston from the said District Parish of All Saints, Pontefract) for a distance of 1 mile or thereabouts to the boundary which divides the said District Parish of All Saints, Pontefract; from the Extra Parochial Place called Pontefract Park, and extending thence north westward along the last mentioned boundary for a distance of 6 chains or thereabouts to the point where it meets the boundary which divides the said New Parish of Saint Paul, Glass Houghton, from the said District Parish of All Saints, Pontefract, and extending thence first north eastward and then in various directions along the last mentioned boundary for a distance of 56 chains or thereabouts to the point where it crosses the middle of Sheep Walk Lane, and extending thence north westward along the middle of Sheep Walk Lane for a distance of 7 chains or thereabouts to its junction with Holywell Lane and Redhill Road, and extending thence north westward along the middle of Redhill Road for a distance of 33 chains or thereabouts to the point beyond Redhill Farmhouse where the boundary which divides the said New Parish of Saint Paul, Glass Houghton, from the said Parish of Ferry Fryston diverges northward from following the northern side of Redhill Road, and extending thence first northward to and then first northward and then in various directions along the last mentioned boundary for a distance in all of 40 chains or thereabouts to the point where it meets the boundary which divides the said Parish of Castleford from the said Parish of Ferry Fryston."

And whereas drafts of the said Scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the Patrons and to the Incumbents of the Cures out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patrons and Incumbents have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Wakefield.
