and be absolutely vested in and shall and may from time to time be exercised by the said Richard Wickham Legg, Archdeacon of Berks, and by his successors in the same Arch-

deaconry for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parlia-

And whereas the said Scheme has been

approved by His Majesty in Council: Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London

Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of

the said Diocese of Oxford.

WHEREAS the Ecclesiastical sioners for England have, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, duly pre-pared, and laid before His Majesty in Council, a Scheme, bearing date the 22nd day of May, 1930, in the words and figures follow-

ing, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District or New Parish for spiritual purposes to be taken out of the Parish of Springfield, in the County of Essex and in the Diocese of Chelmsford:

"Whereas we are satisfied that the said Parish of Springfield is a Parish wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular part of the said Parish of Springfield which is hereinafter mentioned and described should be constituted a separate District or New Parish in the manner which is hereinafter set forth:

"And whereas there is within the limits of the said proposed separate District or New Parish a consecrated Church in use for the purposes of Divine Worship and such Church is named 'The Church of the Holy Trinity, Springfield':

"And whereas by a certain Deed bearing date on or about the 22nd day of May, 1930, and made or expressed to be made under the authority of the 'New Parishes Acts, 1843, 1844 and 1856' or some or one of them between the Reverend Reginald Cecil Collwyn Hargreaves, Rector or Incumbent of the Rectory of the said Parish of Springfield, of the first part, Julia Mary Ann Paynter, of Stoke Hill, Guildford, in the County of Surrey, widow, and the Rever-end Francis Samuel Paynter, of Blackmore House, Blackmore, in the said County of Essex, Clerk in Holy Orders and an Honorary Canon of the Cathedral Church of Chelmsford, the Patrons of the said Rectory of Springfield, of the second part, the Right Reverend Henry, Bishop of Chelmsford, the Ordinary of the said Rectory of Springfield, of the third part, and us, the said Ecclesiastical Commissioners, of the fourth part, the said Reginald Cecil Collwyn Hargreaves did, with the consents of the said Julia Mary Ann Paynter and Francis Samuel Paynter, as such Patrons as aforesaid, and of the said Henry, Bishop of Chelmsford, as such Bishop as aforesaid, grant and confirm unto the Minister of the District or New Parish hereinafter recommended to be constituted and to his successors one perpetual clear yearly rentcharge or net annual sum of £375 to be payable quarterly on the 1st day of January, the 1st day of April, the 1st day of July, and the 1st day of October in every year free from and clear of all deductions taxes charges rates assessments and outgoings whatsoever (except on account of the tax on income or property if any) and to be for ever issuing and payable out of and charged upon all that the said Rectory of Springfield and the Tithes or Tithe Commutation Rentcharges, Glebe lands and hereditaments, and all other the endowments and emoluments for the time being to the said Rectory belonging, the first of such quarterly payments to be made on such of the said quarterly days as shall happen next after the date of the licence of the first Minister of the said proposed District or New Parish, and to be a proportionate part of the said quarterly payment calculated from the date of the said licence to the said quarterly day of payment:

And whereas the said perpetual clear yearly rentcharge or net annual sum of £375 has been granted by the said Reginald Cecil Collwyn Hargreaves as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) the whole right of Patronage of the said proposed District or New Parish and of the nomination of the Minister or Incumbent thereof, should be assigned in the manner which is hereinafter set forth:

whereas the said Reginald Cecil Collwyn Hargreaves has nominated to us the Reverend Ernest Augustus Eardley Wilmot, of Carn Brea, Britton Avenue, Saint Albans, in the County of Hertford, Clerk in Holy Orders and a Prebendary of the Cathedral Church of Wells, the Reverend Francis Edward Murphy, of Walcot Rectory, Bath, in the County of Somerset, Clerk in Holy Orders and a Prebendary of the said Cathedral Church of Wells, the Reverend Charles Edward Wilson, of the Vicarage, Gipsy Hill, London, Clerk in
