The KING has been pleased, by Warrant under His Majesty's Royal Sign Manual, bearing date the 23rd instant, to appoint the Reverend Austen Ernest Lever Whitford, B.A., to the newly-constituted Living of Saint John the Evangelist, Leigh, in the County of Lancaster and Diocese of Manchester.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts, of women of 18 and young persons of 16 years of age and over on winding and pirning at the works of

Messrs. Rayon Manufacturing Co. (1927) Ltd., Ermyn Way, Leatherhead, Surrey, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks; and that suitable accommodation for clothing put off during working hours, mess-room accommodation and washing facilities shall be provided; that additional daily thermometer readings shall be taken and recorded if atmospheric humidity is artificially produced; and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.
