RURAL DISTRICT OF EDEYRNION. PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

B^Y an Order dated the 5th day of June, 1930, the Minister of Health has declared that, on and after the 1st day of July, 1930, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Rural District of Edeyrnion, namely:-

(a) In all the contributory places:

Section 30 (which relates to the repair and enclosure of dangerous places) comprised in Part II (subject, however, to the provisions of Section 33);

- Sections 34 to 37 (inclusive) and 45, comprised in Part III (sanitary provisions); and
- (b) In the contributory place of Corwen:
 - Section 47 (which relates to public conveniences and lavatories) comprised in Part III.
