VARIATION OF MINIMUM RATES OF WAGES FOR
CERTAIN CLASSES OF FEMALE AND MALE
WORKERS.

The Rope, Twine and Net Trade Board (Great Britain) have issued a Notice dated 13th August, 1930, setting out Minimum Rates of Wages for certain classes of Female and Male Workers as varied by the Trade Board and confirmed by Order of the Minister of Labour to take effect as from 18th August, 1930, together with the Minimum Rates of Wages previously in operation which are unaffected by the variation.
