of section 103 (yards and passages to be flagged and drained at the charges of the owner) as relates to any subject matter of section 20 of the Public Health Act, 1925 (courts, &c., to be paved and drained).

The St. Helens Corporation Act, 1911:

Section 18 (power to lay gas pipes in streets not dedicated to public use), section 27 (power to lay water pipes in streets not dedicated to public use), section 47 (further provision as to new streets), section 50 (trees or shrubs overhanging streets and footpaths), section 67 (watercourse not be covered in except in accordance with approved plan), section 68 (power to require watercourses on building land to be culverted), section 69 (Corporation may make communications between drains and sewers), section 73 (street orderly bins), paragraphs (a) and (b) of subsection (1) of section 80 (for regulating manufacture and sale of icecream), section 86 (extension of section 126 (2) of Public Health Act, 1875), section 94 (defining establishing of a new business), section 99 (power medically to examine inmates of common lodging-houses where infectious disease is supposed to exist), and section 102 (as to public vehicles taken at railway station).

The St. Helens Corporation Act, 1921:

Section 40 (lopping of trees overhanging highways), and section 72 (rag and bone dealers not to sell food).
