#### 14. PENALTIES FOR BREACH OF THESE REGULATIONS.

(1) If any Coalowner shall commit a breach of any of these Regulations or shall infringe or depart from any of the resolutions or decisions of the Executive Board or the Central Sale Committee hereunder he shall pay on demand to the Trustees a sum equal to three shillings for every ton of the tonnage of coal involved in any transaction in respect of which a breach or default has been committed unless in the opinion of the Executive Board such breach or default shall not have endangered delayed or injured the purposes or objects of the Scheme (including these Regulations) or the interests of any Coalowner in the District.

(2) Every determination of the Executive Board made under this Clause shall be expressed in a certificate in writing to the Trustees under the hands of the Chairman and Secretary of the Executive Board.

(3) All monies received or recovered by the Trustees under this Clause shall form part of the District Fund.
