WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 16th day of October, 1930, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Walton, in the County of Cumberland, and in the Diocese of Carlisle:

"Whereas by the Will dated the 17th day of March, 1920, of the late Margaret Dacre, of Irthington, in the County of Cumberland, widow, the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Walton was devised to the Bishop of Carlisle and his successors:

"And whereas the said Margaret Dacre died on the 14th day of March, 1922:

"And whereas Anthony Nichol Bowman, of Number 3, Castle Street, Carlisle, in the said County of Cumberland, Solicitor, and Sir John Prosser, C.V.O., of Number 19, York Place, Edinburgh, in the County of Midlothian, Writer to the Signet, are the executors of the said Will, in whom, but for the hereinbefore recited devise the said Advowson would now be vested, and they are desirous with a view to the confirmation of the said

devise, that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Walton should be transferred to and be vested in the Bishop of Carlisle for the time being in the manner hereinafter recommended and proposed:

"And whereas the Right Reverend Henry Herbert, now Bishop of Carlisle, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Henry Herbert, Bishop of Carlisle, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Walton, which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Walton:

"Now, therefore, with the consent of the said Anthony Nichol Bowman and John Prosser (in testimony whereof they have signed and sealed this Scheme) and with the consent of the said Henry Herbert, Bishop of Carlisle (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), and by way of confirmation of the hereinbefore recited devise by the Will of the said Margaret Dacre, we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Walton shall be transferred to the said Henry Herbert, Bishop of Carlisle, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Henry Herbert, Bishop of Carlisle, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."
