Overtime Rates calculated in the proposed minimum rates specified in Parts I and II of this Schedule in the manner set out in part III of the Trade Board's Notice H.L. (10)dated 8th September, 1922, shall apply in substitution for the General Minimum Time-Rates and Piece-Work Basis Time-Rate set out in Parts I and II of this. Schedule in respect of all hours worked in excess of the number of hours declared by the Trade Board in the Schedule to their said Notice H.L. (10) to be the normal number of hours of work in the trade.
