ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 15TH NOVEMBER, 1930.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Authorisation of Landing of Animals for Exhibition.

1. The landing of any ruminating animals or swine, the property of the Zoological Society of London, which are intended for exhibition in the Gardens of that Society, is hereby allowed, subject to the provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of Part VI of the Animals (Importation) Order of 1930, and of this Order.

Definition of Quarantine Station.

2. The premises described in the Schedule hereto are hereby defined as an Imported Animals Quarantine Station for the purpose of the landing and detention of any such animals as may be landed in accordance with the provisions of this Order.

Examination before Landing.

3. No such animal shall be landed except with a licence granted by an Inspector of the Ministry, which licence shall not be granted unless and until the animal has been examined by a Veterinary Inspector of the Ministry and certified by him to be free from symptoms of disease.

Prescribed Period of Quarantine.

4. Such animals on being landed, shall forthwith be moved under the supervision of an Inspector of the Ministry of Agriculture and Fisheries from the quay to the premises described in the Schedule hereto, and shall be there detained for a period of twentyeight days or such other period as may be specified in the licence authorising the landing of the animals. During the said period the animals shall be isolated from all other animals, and no other animal shall be moved into such premises.

Revocation.

5. The Order of the Minister (No. 782) dated the 29th November, 1921, relating to the landing of animals intended for exhibition in the Gardens of the Zoological Society of London is hereby revoked.
