## MERCHANT SHIPPING.

FEES.

THE MERCHANT SHIPPING (FEES) AMENDMENT ORDER, 1930, DATED NOVEMBER 24, 1930, MADE BY THE BOARD OF TRADE UNDER THE MERCHANT SHIPPING ACT, 1894 (57 & 58 VICT. C. 60), AS AMENDED BY THE FEES (INCREASE) ACT, 1923 (13 & 14 Geo. 5. c. 4).

1. In pursuance of the powers conferred on the Board of Trade by the Merchant Shipping Act, 1894 (57 & 58 Vict. c. 60) as amended by the Fees (Increase) Act, 1923 (13 & 14 Geo. 5. c. 4), and the Economy (Miscellaneous Provisions) Act, 1926 (16 & 17 Geo. 5. c. 9), and of any other power in that behalf, the Board hereby direct that the reduction of 163 per cent. allowed under the Merchant Shipping (Fees) Amendment Order, 1929, (a) on the fees therein specified shall be cancelled.

2. The Merchant Shipping (Fees) Amendment Order, 1929, is accordingly hereby revoked.

3. This Order may be cited as the Merchant Shipping (Fees) Amendment Order, 1930, and shall take effect as from the 1st day of December, 1930.
