Notice is hereby given by the Minister of Transport that in pursuance of the powers vested in him by sub-section (2) of Section 123 of the Road Traffic Act, 1930 (hereinafter called "the Act"), he has, by the Road Traffic Act, 1930 (Date of Commencement) Order (No. 2), 1930, appointed and ordered that the provisions of the Act hereinafter mentioned shall come into operation on the dates and for the purposes shown hereunder.
