instrumental in saving the lives of a number of natives who would have otherwise, been gassed.

The two men who afterwards went in search of him lost their lives by gas in the attempt, and Bell himself would probably have shared their fate had he not, when he became unconscious, fallen with his mouth next to a leak in a compressed air pipe.
