

APPOINTMENT OF A STANDING FOR HACKNEY CARRIAGES WITHIN THE METROPOLITAN POLICE DISTRICT, AND REGULATIONS TO BE OBSERVED.

By virtue of the Act 13 and 14 Victoria, chapter 7, intituled "An Act for Consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of Commissioners of Police of the Metropolis, and making other provisions in regard to the Consolidated Offices."

I, the undersigned, Commissioner of Police of the Metropolis, do hereby APPOINT a Standing for Hackney Carriages at the following place, and do make the following Regulations with regard to the Boundaries for the same, viz. :—

21st November, 1930.

APPOINTMENT.

AT WESTBOURNE GROVE AND NORFOLK ROAD, PADDINGTON.

In two portions.

Eleven Hackney Carriages:

First Portion.—Three carriages at Westbourne Grove, in centre of roadway, commencing at a point in line with lamp-post No. 122, Westbourne Grove, extending Westward, as far as necessary for three carriages.

Front of vehicles toward the East.

Second Portion.—Eight carriages at Norfolk Road, in centre of roadway, commencing three yards North of the stone sett crossing at junction of Westbourne Grove, extending Northward, as far as necessary for eight carriages.

Front of vehicles toward the South.

The first portion of the Standing to be fed exclusively by carriages from the second portion.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.
