GILLINGHAM CORPORATION.

NOTICE is hereby given that application has been made to Parliament in the present Session by the Mayor Aldermen and Burgesses of the Borough of Gillingham (hereinafter called "the Corporation" and "the Borough" respectively) for an Act of which the principal subject matters are as follows:—

1. Further provisions with regard to the electricity undertaking of the Corporation and the supply of electricity by them; including further powers as to entry upon premises for inspection and for removal of meters and fittings; electric substations in streets; transforming stations; electric wires in private streets; supply of electricity in bulk; the cutting off of supplies and power to recover cost of cutting off where charges not paid;

byelaws as to apparatus and fittings; charges for special readings of meters and other matters.

2. Further provision with regard to hackney carriages and with regard to the control of traffic and other police matters and the good government of the borough.

3. Further and better provision with regard to streets, buildings, forecourts, sewers and drains, petroleum filling stations, slaughterhouses and common lodging houses, for the prevention of infectious and other diseases and with reference to sanitary matters, the sorting and tipping of refuse and for securing the purity of food.

4. The provision of and further powers with regard to swimming and other baths and bathing pools and the user of swimming baths belonging to the Corporation for exhibitions, entertainments, etc.

5. Further provisions with regard to the acquisition, utilisation, retention, exchange and development of lands.

6. Further powers with regard to the sale of coke.

7. To prohibit or regulate street trading within the borough.

8. The borrowing of money for all or any of the purposes of the intended Act, and other financial provisions, including the establishment of an insurance fund, lands fund, education accident fund, repairs and renewals fund and a consolidated loans fund; provision with regard to the revenue and expenses of the Corporation's undertakings and the accounts thereof; the use of moneys standing to the credit of any loans fund or other funds instead of borrowing; the borrowing of money by the issue of bonds; power to use one form of mortgage for all purposes; the substitution of professional auditors for the borough auditors; the granting of gratuities and allowances to officers and servants and their families in certain cases.

9. To remove the restriction imposed by Article 27 of the Gillingham Pier Order 1912 (confirmed by the Pier and Harbour Orders Confirmation (No. 2) Act, 1912) as to the rate of interest at which money can be borrowed thereunder.

10. To enact provisions enabling the Minister of Health on the application of the Corporation to extend the Rochester and Chatham Joint Sewerage District constituted by the Rochester and Chatham Joint Sewerage Order 1904 so as to include the borough and to enable the Minister to make any necessary or consequential alterations in the constitution of the Joint Sewerage Board.

11. The incorporation, repeal and amendment of Acts and Orders and enactment of incidental and miscellaneous provisions including powers as to the erection of a Town Hall and Municipal Buildings and the erection of shops, etc., in connection therewith and leasing of the same.
