

MINISTRY OF TRANSPORT.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport, after the expiration of at least forty days from this date, in pursuance of the powers conferred upon him by Section 7 of the aforesaid London Traffic Act, to make Regulations amending the London Traffic (Restricted Streets) Regulations.

And notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Restricted Streets) Amendment (Routes Nos. 214, 231, 266 and 526D) Provisional Regulations, 1930, to come into operation forthwith as Provisional Regulations to continue in force until Regulations have been made in accordance with the provisions of Section 1 of that Act.

These Regulations provide for a re-arrangement of the omnibus services on Routes Nos. 214, 231, 266 and 526D.

LAND DRAINAGE ACT, 1930.

NOTICE OF THE MAKING OF AN ORDER BY THE MINISTER OF AGRICULTURE AND FISHERIES.

Notice is hereby given that the Minister of Agriculture and Fisheries has settled and made an Order under the Land Drainage Act, 1930, constituting the Drainage Board of the Ouse (Great) Catchment Area.

Copy of the Order may be seen at all reasonable hours at the offices of the Ministry of Agriculture and Fisheries, 10, Whitehall Place, London, S.W. 1.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement

of the Act has not been complied with, he may, within six weeks after the publication of this notice make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.
