"That pursuant to the directions contained in the 26th Section of the Pluralities Act, 1838, I the said Lord Bishop have drawn up a Scheme in writing appended to this Representation describing the mode in which it appears to me that the alterations above proposed may be best effected and how the changes consequent on such alterations in respect of Ecclesiastical jurisdiction, Glebe lands, Tithes, rent charges and other ecclesiastical dues, rates and payments and in respect to Patronage and rights to pews may be made with justice to all parties interested. And I do submit the same to Your Grace together with the consents thereto in writing of the Most Honourable William Thomas Brownlow Marquess of Exeter Baron Burghley of Burghley House in the County of Northampton, the Patron, and the Reverend Charles Alfred Peacock, the Incumbent of the said Benefice of Stamford Saint Peter with all Saints; The Most Honourable William Thomas Brownlow Marquess of Exeter Baron Burghley of Burghley House in the County of Northampton, the Patron of the said Benefice of Saint George with Saint Paul in Stamford; Florence Zita Egan-Newcomb of 24A Curzon Street in the County of London, Married Woman, the Patron, and the Reverend Harry Stephen Pegg, the Incumbent of the said Benefice of Saint John with Saint Clement in the Borough of Stamford; The Most Honourable William Thomas Brownlow Marquess of Exeter Baron Burghley of Burghley House in the County of Northampton, the Patron, and the Reverend Thomas Holden Bailey, the Incumbent of the said Benefice of Saint Mary in the Borough of Stamford; and the Most Honourable William Thomas Brownlow Marquess of Exeter Baron Burghley of Burghley House in the County of Northampton, the Patron, and the Reverend John Henry Bell Hamond, the Incumbent of the said Benefice of Saint Michael with Saint Andrew and Saint Stephen within the Borough of Stamford (with the exception of the present Incumbent of the Benefice of Saint George with Saint Paul in Stamford) to the intent that if Your Grace shall on full consideration and enquiry be satisfied with such Scheme you may certify the same and such consents aforesaid to His Majesty in Council.

And whereas the said Scheme drawn up by the said Bishop and the Consents referred to in the said Representation are as follows:—

"SCHEME.

"It is proposed to separate from the Parish of Saint John with Saint Clement in the Borough of Stamford and annex to the Parish of Stamford Saint Peter with All Saints all that portion of the Parish of Saint John with Saint Clement in the Borough of Stamford which is delineated on the said map or plan hereto annexed and thereon verged red.

"It is also proposed to separate from the respective Parishes of Stamford Saint Peter

with All Saints and Saint Michael with Saint Andrew and Saint Stephen within the Borough of Stamford and annex to the Parish of Saint George with Saint Paul in Stamford all those portions respectively of the respective Parishes of Stamford Saint Peter with All Saints and Saint Michael with Saint Andrew and Saint Stephen within the Borough of Stamford which are delineated on the said map or plan hereto annexed and thereon verged blue and black respectively.

"It is also proposed to separate from the Parish of Stamford Saint Peter with All Saints and annex to the Parish of Saint John with Saint Clement in the Borough of Stamford all that portion of the Parish of Stamford Saint Peter with all Saints which is delineated on the said map or plan hereto annexed and thereon verged yellow.

"It is also proposed to separate from the respective Parishes of Stamford Saint Peter with All Saints; Saint George with Saint Paul in Stamford; Saint John with Saint Clement in the Borough of Stamford; and Saint Michael with Saint Andrew and Saint Stephen within the Borough of Stamford; and annex to the Parish of Saint Mary in the Borough of Stamford all those portions of the respective Parishes of Stamford Saint Peter with All Saints; Saint George with Saint Paul in Stamford; Saint John with Saint Clement in the Borough of Stamford; and Saint Michael with Saint Andrew and Saint Stephen within the Borough of Stamford which are delineated on the said map or plan hereto annexed and thereon verged green, purple, orange and light brown respectively.

"It is also proposed to separate from the respective Parishes of Stamford Saint Peter with All Saints and Saint George with Saint Paul in Stamford and annex to the Parish of Saint Michael with Saint Andrew and Saint Stephen within the Borough of Stamford all those portions respectively of the respective Parishes of Stamford Saint Peter with All Saints and Saint George with Saint Paul in Stamford which are delineated on the said map or plan hereto annexed and thereon verged grey and dark brown respectively.

"That the Incumbents of Stamford Saint Peter with All Saints, Saint George with Saint Paul in Stamford, Saint John with Saint Clement in the Borough of Stamford, Saint Mary in the Borough of Stamford and Saint Michael with Saint Andrew and Saint Stephen within the Borough of Stamford shall have sole and exclusive cure of souls within those portions of the Parishes so to be separated from the Parishes of Saint John with Saint Clement in the Borough of Stamford, Stamford Saint Peter with All Saints, Saint George with Saint Paul in Stamford and Saint Michael with Saint Andrew and Saint Stephen within the Borough of Stamford respectively and annexed to their respective Parishes.

"That the inhabitants of such portions so to be separated shall be entitled to accommodation in the respective Parish Churches of the Parishes to which the portions are to be so annexed but shall cease to be entitled to any right of accommodation in the Parish Churches of the Parishes from which the several portions are respectively separated except nevertheless any person or persons (if any) possessing a legal right by Faculty or otherwise to any
