The Civil Service Commissioners hereby give notice that an Open Competitive Examination will be held in London, the written work commencing on the 7th July, 1931, under the Regulations respecting Open Competitive Examinations for the situations of Assistant Inspector of Taxes in the Inland Revenue Department and Third Class Officer in the Ministry of Labour, dated the 29th January, 1929, and published in the London Gazette of the same date.

Not fewer than 30 vacancies for Assistant Inspectors of Taxes will be filled on the result of this Examination, if so many candidates should be found to be qualified in all respects. It cannot yet be stated whether any vacancies for Third Class Officers will be filled on the result of this competition; an announcement on this point will be made at a later stage.

No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 7th May, 1931, an application, in the Candidate's own handwriting, on a prescribed form, which may be obtained from the Secretary at once.
