## CENSUS SPECIAL REGULATIONS.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Health, after the expiration of at least 40 days from this date, in exercise of the powers conferred upon him by sub-section (1) of Section 3 of the Census Act, 1920, to make Regulations entitled the Census Special Regulations, 1931.

And that on account of urgency the Minister of Health under Section 2 of the Rules Publication Act, 1893, has made Regulations entitled the Census Special Provisional Regulations, 1931, to come into force immediately as provisional regulations, to continue in force until regulations have been made in accordance with the provisions of Section 1 of that Act.
