The effect of the new Regulations is to exempt from the application of the Dangerous Drugs Regulations five preparations containing Diacetylmorphine (Heroin) which the Health Committee of the League of Nations has found cannot give rise to the drug habit on account of the medicaments with which the Diacetylmorphine is compounded in them.
