

(2) TO VARY certain conditions with regard to the employment of LEARNERS AND INDENTURED APPRENTICES;

(3) TO VARY certain of the GENERAL MINIMUM PIECE-RATES set out in the Schedule to their Notice D.(40), dated 28th June, 1929; and

(4) TO FIX ADDITIONAL GENERAL MINIMUM PIECE-RATES.

Particulars of the proposed variations and of the General Minimum Piece-Rates which it is proposed to fix may be obtained on application to the Secretary of the Trade Board.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board WILL CONSIDER ANY OBJECTIONS to the above Proposal to Vary and to Fix which may be lodged with them within two months from the 24th February, 1931. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary, Boot and Shoe Repairing Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W. 1. It is desirable that Objections should state precisely, and so far as possible, with reasons what is objected to.
