*Declaration of Foot-and-Mouth Disease Infected Area.*

1. The Area described in the Schedule to this Order is hereby declared to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

*Short Title.*

2. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1931 (No. 7) and shall be read with the Order referred to in Article 1.

LAND DRAINAGE ACT, 1930.

*River Cuckmere Catchment Area.*

Notice is hereby given that the Minister of Agriculture and Fisheries, in exercise of the powers conferred upon him under Section 4 (3) of the Land Drainage Act, 1930, proposes to make an Order confirming a scheme submitted by the River Cuckmere Catchment Board under Section 4 (1) (a) of the above Act, for the transfer to the Catchment Board of all rights, powers, duties, obligations and liabilities over or in connection with the main river as were immediately before the commencement of the said Act vested in or to be discharged by any drainage authority, and of any property held by the authority for the purpose of, or in connection with, any functions so transferred.

A copy of the draft Order has been deposited at the Office of the Rural District Council of Eastbourne, 4 and 5, Station Parade, Eastbourne, for public inspection for a period of one month from the date of this notice and may be inspected between the hours of 10 a.m. and 1 p.m. and 2.30 p.m. and 5 p.m. on any weekday except Saturday when the hours of inspection will be from 10 a.m. to 12.30 p.m.
