IN THE MATTER OF THE BANKRUPTCY
ACT, 1914.

Whereas the Board of Trade by Minute dated the 15th February, 1928, appointed Mr. Frederick Murgatroyd to be Senior Official Receiver and Mr. John Davis Turner to be Official Receiver for the Bankruptcy Districts of the County Courts holden at Manchester, Bolton, Ashton-under-Lyne and Stalybridge, Oldham, Rochdale, Stockport, and Salford, such appointments to take effect from the 9th March, 1928.

And whereas by a Direction dated the 7th March, 1928, the Board of Trade provided for the assignment as therein mentioned of Receiving Orders made by the said Courts to Mr. Frederick Murgatroyd and to Mr. John Davis Turner.

And whereas on the 16th February, 1931, Mr. John Davis Turner ceased by reason of promotion to be such Official Receiver as aforesaid.

And whereas by a Minute dated the 16th February, 1931, the Board of Trade appointed Mr. Arthur Harold Ward to discharge the duties of Official Receiver for the Bankruptcy Districts of the County Courts holden at Ashton-under-Lyne and Stalybridge, Bolton, Oldham, Rochdale and Stockport, until a successor should be appointed in the place of Mr. John Davis Turner.

And whereas by Minute dated the 28th March, 1931, the Board of Trade appointed Mr. Rudolf Kynoch Clark to be Official Receiver for the Bankruptcy Districts mentioned in the first paragraph hereof as from the 30th March, 1931, in the place of Mr. John Davis Turner.

Now therefore the Board of Trade, by virtue of Rule 308 of the Bankruptcy Rules, 1915, hereby vary the above recited Direction dated the 7th March, 1928, and hereby direct that where Receiving Orders have been made by the said County Courts holden at Bolton, Ashton-under-Lyne and Stalybridge, Oldham, Rochdale and Stockport, respectively, prior to the 30th March, 1931, and are pending at that date, and where Receiving Orders are made on and after the 30th March, 1931, by the last mentioned County Courts respectively, Mr. Rudolf Kynoch Clark shall be the Official Receiver in the place of Mr. John Davis Turner and Mr. Arthur Harold Ward respectively, for the purposes of such Receiving Orders and the estates thereunder shall be assigned to him.

This direction shall have effect as from and including the 30th March, 1931.
