(2) The animals shall be detained and isolated in the said Quarantine Station in accordance with the provisions of the Principal Order for a period of twenty-eight days after landing and if moved therefrom the animals shall be accompanied by the certificate and licence required by Article 40 (8) of the Principal Order.

(3) A copy of every licence authorising the movement of any animal described in the First Schedule hereto shall be forwarded to the Ministry by the Inspector who grants the Licence.

#### ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 30TH MARCH, 1931.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

##### *Authorisation of Landing of Animals for Exceptional Purposes.*

1. The landing of the animals described in the First Schedule hereto is hereby allowed subject to the Provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and Part VI (Animals intended to be landed at an Imported Animals Quarantine Station) of the Animals (Importation) Order of 1930 hereinafter referred to as the "Principal" Order and of this Order.

##### *Definition of Quarantine Station.*

2. The premises described in the Second Schedule hereto are hereby defined as an Imported Animals Quarantine Station for the purpose of the landing and detention of the animals described in the First Schedule hereto.

##### *Regulations applicable to the animals before and on Landing.*

3.—(1) The animals before being landed, shall be examined by a Veterinary Inspector of the Ministry, and if found by him to be free from symptoms of disease, shall forthwith be landed and moved in a float, cart, van, or other suitable vehicle under the supervision of the Inspector from the place of landing to the Imported Animals Quarantine Station described in the Second Schedule hereto; the said vehicle shall be cleansed and disinfected before and after such use in the manner prescribed by the Inspector.

(2) The animals shall be detained and isolated in the said Quarantine Station in accordance with the provisions of the Principal Order for a period of twenty-eight days after arrival thereat, and when moved therefrom the animals shall be accompanied by the certificate and licence required by Article 40 (8) of the Principal Order.

The Minister of Agriculture and Fisheries by virtue and in exercise of the powers vested in him under the Destructive Insects and Pests Acts, 1877 to 1927, and of every other power enabling him in that behalf, orders as follows:—

##### *Examination of Fruit Trees.*

1. If it appears to the Local Authority from a complaint made to it by a grower of fruit trees that there is reason to suspect that any fruit trees growing on any premises within the district are so affected with any of the pests specified in the Schedule to this Order that any such pest is likely to spread to fruit trees growing on his premises, it shall thereupon cause an Officer (hereinafter called "the
