

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts of women of 18 in twisting artificial silk over woollen yarn in the 24th room of Middle Mill at the works of Messrs. Kelsall & Kemp, Ltd., The Butts, Rochdale, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that suitable accommodation for clothing put off during working hours and messroom accommodation shall be provided.

Thomas Taylor & Sons, Ltd., Grecian Mills, Lever Street, Bolton, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that suitable accommodation for clothing put off during working hours, messroom accommodation and washing facilities shall be provided; and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance, or otherwise for the welfare of such workers, as may be necessary to prevent hardship.
