GODALMING.

Whereas the Mayor, Aldermen and Burgesses of the Borough of Godalming (hereinafter called the Corporation), being the Urban Sanitary Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Godalming Corporation Water Act, 1899, so as:—

(1) To provide that the rates and charges for the supply of water by the Corporation shall be payable half-yearly in advance on the first day of April and the first day of October in every year, but so that the same shall not be recoverable until the expiration of two months after these respective days;

(2) To provide that any person who shall occupy any premises during part only of any half-year in respect of which the water rate, or charges are demanded shall be liable for a part of such rates or charges proportionate to that part of the half-year;

(3) For the purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, in force in the said Borough as may be necessary or desirable;

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is hereby given that the Minister of Health will consider any objections or representations made in writing before the 4th day
