#### *Civil Service Commission,*

The Civil Service Commissioners hereby give notice that an Open Competitive Examination for situations as Male Assistant Preventive Officer in the Waterguard Service of the Customs and Excise Department will be held, commencing on the 28th August, 1931, under the Regulations dated the 22nd June, 1928, and published in the London Gazette of the same date; the first part of the examination will be held in Bristol, Glasgow, Hull, Liverpool, London, Newcastle-on-Tyne, and Southampton.

#### MINISTRY OF HEALTH.

##### LOCAL GOVERNMENT ACT, 1929.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Health, after the expiration of at least 40 days from this date, in exercise of the powers conferred upon him by the Local Government Act, 1929, to make Regulations entitled the Local Government (Adjustment of Gains and Losses in County Districts) (First Fixed Grant Period) (Amendment) Regulations, 1931.

And that on account of urgency the Minister of Health, under Section 2 of the Rules Publication Act, 1893, has made Regulations entitled the Local Government (Adjustment of Gains and Losses in County Districts) (First Fixed Grant Period) (Amendment) Provisional Regulations, 1931, to come into force immediately as provisional regulations, to continue in force until regulations have been made in accordance with the provisions of Section 1 of that Act.
