

FACTORY AND WORKSHOP ACTS,
1901 TO 1929.

The Secretary of State for the Home Department hereby gives notice in pursuance of Section 86 (1) of the Factory and Workshop Act, 1901, that on 1st June, 1931, he made Regulations under Section 79 of the Act for factories and workshops or parts thereof in which the electrolytic plating or oxidation of metal articles by the use of an electrolyte containing chromic acid or other chromium compounds is carried on.

The Regulations, which are in accordance with the revised draft issued on 31st March last, may be cited as the Chromium Plating Regulations, 1931, and will come into force on 1st August, 1931.
