

and New Malden ("The Fountain") declared to be "restricted streets" by any Order made by the Minister of Transport under the aforesaid Section of the London Traffic Act, 1924, and forming part of that approved route twenty-one journeys in each direction with his omnibuses plying for hire on that approved route in excess of the number of journeys which he may make in those streets or parts thereof under the said Regulations; provided that nothing herein contained shall be deemed to affect or derogate from the powers of the Commissioner of Police of the Metropolis under the provisions of Section 52 of the Metropolitan Police Act, 1839, to give directions to constables for keeping order and for preventing any obstruction of the thoroughfares.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

Notice is hereby given that the Minister of Transport in exercise of the powers conferred upon him by Section 10 of the aforesaid London Traffic Act, has, by virtue of Section 2 of the Rules Publication Act, 1893, made the London Traffic (Prescribed Routes) (No. 2) Provisional Regulations, 1931, to come into force on the 29th day of June, 1931, as Provisional Regulations to continue in force until Statutory Rules have been made in accordance with the last mentioned Act.

These Regulations, which revoke the London Traffic (Prescribed Routes) Amendment Provisional Regulations, 1929, provide for the introduction of revised traffic working in Aldwych, Arundel Street, Surrey Street and East Strand and for the continuance of the following traffic schemes:—

(1) One-way traffic working along the duplicate carriageways of a part of Eastern Avenue and a part of the Woodford-Ilford Road.

(2) One-way traffic working in Melbourne Place and on each side of St. Clement Danes Church, Strand.

(3) Roundabout traffic working at the junction of the London-Portsmouth Main Road and the Leatherhead-Surbiton Main Road.

(4) "Roundabout" traffic working at the junction of Eastern Avenue, Cranbrook Road and the Woodford-Ilford Road.

River Wyre Catchment Area.
