

At the Court at *Buckingham Palace*, the 29th day of June, 1931.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Supplementary Scheme bearing date the 11th day of June, 1931, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council the following Supplementary Scheme, under the 11th Section of that Measure, with reference to the house of residence for the Incumbent of the United Benefice of Grateley with Quarley, situate in the County of Southampton and in the Diocese of Winchester :

“ Whereas by an Order of Your Majesty in Council dated the 15th day of May, 1930, and published in the London Gazette on the 16th day of the same month, it was directed that upon the union of the Benefices of Quarley and Grateley taking effect the Parsonage House then belonging to the said Benefice of Grateley should become and be the house of residence for the Incumbent of the United Benefice :

“ And whereas the union of the said Benefices of Quarley and Grateley has since taken effect :

“ And whereas the said United Benefice of Grateley with Quarley is now full, the Reverend Reginald Henry Arthur Currey being the present Incumbent thereof :

“ And whereas it has been represented to us, the said Ecclesiastical Commissioners, and it appears to us to be expedient that the provisions hereinbefore referred to in regard to the house of residence for the Incumbent of the United Benefice of Grateley with Quarley contained in the said Order of Your Majesty in Council should be altered as hereinafter recommended and proposed :

“ Now, therefore, we, the said Ecclesiastical Commissioners with the consent of the Right Reverend Theodore, Bishop of Winchester (testified by his signing this Scheme), and with the consent of the said Reginald Henry Arthur Currey (testified by his signing this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

“ That the provisions of the said Order in Council of the 15th day of May, 1930, shall be altered in the following manner, that is to say that the Parsonage House formerly belonging to the said Benefice of Quarley (instead of the Parsonage House formerly belonging to the said Benefice of Grateley) shall become and be the house of residence for the Incumbent of the United Benefice of Grateley with Quarley and that so soon as conveniently may be the Parsonage House formerly belonging to the said Benefice of Grateley and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall be sold and disposed of by us, the said Ecclesiastical Commissioners, at such time or times and in such manner in all respects as to us shall seem expedient and that so much of the net proceeds of such sale as shall appear to us

the said Ecclesiastical Commissioners, and to the Bishop of Winchester to be desirable shall be applied by us for and towards the cost of improvements to the Parsonage House of the United Benefice and that the residue of such net proceeds shall be held and invested by us, the said Ecclesiastical Commissioners, for the benefit of the United Benefice of Grateley with Quarley.

“ Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Union of Benefices Measure, 1923, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament.”

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923 :

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners :

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Winchester has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid :

And whereas the said Scheme has been approved by His Majesty in Council :

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Winchester.
