## PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 39, and laid before His Majesty in Council, a Scheme bearing date the 25th day of June, 1931, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty, Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or per-

petual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Rusper, in the County of Sussex and in the Diocese of Chichester:

"Whereas the Advowson or perpetual right
of Patronage of and presentation to the said
Benefice of Rusper is vested for an estate in
fee simple without incumbrances in Elizabeth
Ann Florence Edgeworth, of Number 22, Bedford Gardens, Kensington, London, Spinster:

"And whereas the said Elizabeth Ann

Florence Edgeworth is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Rusper now vested in her as aforesaid, should be transferred to and be vested in Herbert Ryding Mosse, of Roffey House, Horsham, in the County of Sussex, a Doctor of Medicine, Katharine Mosse, wife of the said Herbert Ryding Mosse, and the Reverend Charles Herbert Mosse, of Trinity House, Rushams Road, Horsham aforesaid, Clerk in Holy Orders, and the Right Reverend George Kennedy Allen now Bishop of Chichester and his successors in the same Bishopric, to hold as joint tenants during the lifetime of the said Herbert Ryding Mosse, Katharine Mosse and Charles Herbert Mosse or of the survivor of them, and should, after the decease of the said Herbert Ryding Mosse, Katharine Mosse, and Charles Herbert Mosse, or of the survivor of them, be vested in the Bishop for the time being of the said Diocese of Chichester:
