ORDER OF THE MINISTER OF
AGRICULTURE AND FISHERIES.

(DATED 14TH JULY, 1931.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

*Authorisation of Landing of Animals for
Exceptional Purposes.*

(1) The landing of the animals described in the First Schedule hereto, which are intended for exceptional purposes, is hereby allowed subject to the provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894 and Part VI (Animals intended to be landed at an Imported Animals Quarantine Station) of the Animals (Importation) Order of 1930 hereinafter referred to as the "Principal" Order, and of this Order.

Definition of Quarantine Station.

(2) The premises described in the Second Schedule hereto are hereby defined as an Imported Animals Quarantine Station for the purposes of the Landing and detention of the animals described in the First Schedule hereto.

*Regulations applicable to the animals before
and on Landing.*

(3) (i) The animals before being landed shall be examined by a Veterinary Inspector of the Ministry, and if found by him to be free from symptoms of disease, shall forthwith be landed and moved in a float, cart, van or other suitable vehicle under the supervision of the Inspector from the place of landing to the Imported Animals Quarantine Station described in the Second Schedule hereto; the said vehicle shall be cleansed and disinfected before and after such use in the manner prescribed by the Inspector.

(ii) The animals shall be detained and isolated in the said Quarantine Station in

accordance with the provisions of the Principal Order for a period of twenty-eight days after landing and if moved therefrom the animals shall be accompanied by the certificate and licence required by Article 40 (8) of the Principal Order.

(iii) A copy of every licence authorising the movement of any animal described in the First Schedule hereto shall be forwarded to the Ministry by the Inspector who grants the Licence.

LAND DRAINAGE ACT, 1930.

River, Derwent Catchment Area.

Notice is hereby given that the Minister of Agriculture and Fisheries has prepared a map determining the extent of the River Derwent Catchment Area, and showing that part of the channel of the river which is to be treated as the main river for the purposes of Part II of the Land Drainage Act, 1930, and the water-courses which are for those purposes to be deemed to be part of the main river coloured thereon in red.

A copy of the map has been deposited at the office of the Rural District Council, Grecian Villa, Cockermouth, for public inspection for a period of one month from the date of this notice, and may be inspected between the hours of 9 a.m. and 5.15 p.m., on any week-day except Saturday, when the hours of inspection will be from 9 a.m. to 12 noon.

A copy of the map may also be inspected at the offices of the Ministry between the hours of 10 a.m. and 4.30 p.m. on any week-day and on Saturday between the hours of 9.30 a.m. and 12 noon.
