PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

NOTICE is hereby given that by an Order dated the first day of July, 1931, the Minister of Health has confirmed an Order made on the thirteenth day of April, 1931, by the Council of the Urban District of Rhyl in pursuance of Section 112 of the Public Health Act, 1875, as amended by Section 51 of the Public Health Acts Amendment Act, 1907, declaring the trade or business of a chip potato frier within the Urban District of Rhyl to be an offensive trade.
