

such case notice in writing specifying the number of animals and the lair to which they have been moved shall forthwith be given by the owner or person in charge of the animals to the Local Authority. The movement of the animals from the lairs to the slaughterhouse shall take place within the period allowed for slaughter.

*Commencement.*

2. This Order shall come into operation on the twenty-seventh day of July, nineteen hundred and thirty-one.

*Short Title.*

3. This Order may be cited as the ANIMALS (LANDING FROM IRELAND AND ISLE OF MAN) ORDER OF 1931 (No. 4).

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 24TH JULY, 1931.)

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1931 (No. 33).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

*Release of the Perthshire, Kinross-shire and Fifeshire Foot-and-Mouth Disease Infected Area from Restrictions.*

1. The Area described in the Third Schedule to the Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 31) shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925 on the twenty-ninth day of July, nineteen hundred and thirty-one.

*Further Contraction of the Lancashire Foot-and-Mouth Disease Infected Area.*

2.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 12) as amended by the Foot-and-Mouth Disease (Infected Areas) Orders of 1931 (Nos. 13, 25 and 29) shall be read and have effect as if the Area described in the First Schedule to this Order were substituted for the Infected Area described in the Schedule to the Foot-and-Mouth

Disease (Infected Areas) Order of 1931 (No. 29).

(2) This Article shall come into operation on the twenty-ninth day of July, nineteen hundred and thirty-one.

*Release of the Dalston (Cumberland) Foot-and-Mouth Disease Infected Area from Restrictions.*

3. The area described in the Schedule to the Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 32) shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925, on the thirtieth day of July, nineteen hundred and thirty-one.

*Contraction of the Kilconguhar (Fifeshire) Foot-and-Mouth Disease Infected Area.*

4.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 14) as amended by the Foot-and-Mouth Disease (Infected Areas) Orders of 1931 (Nos. 16, 19, 26 and 30) shall be read and have effect as if the Area described in the Second Schedule to this Order were substituted for the Infected Area described in the Second Schedule to the Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 30).

(2) This Article shall come into operation on the thirtieth day of July, nineteen hundred and thirty-one.

*Release of the Tibbermore (Perthshire) Foot-and-Mouth Disease Infected Area from Restrictions.*

5. The Area described in the Second Schedule to the Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 31) shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925 on the first day of August, nineteen hundred and thirty-one.

*Short Title.*

6. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1931 (No. 33).

FIRST SCHEDULE.

An Area comprising:—

*In the county of Lancaster.*

The petty sessional division of Garstang (except the parish of Bleasdale); and the parishes of Little Eccleston with Larbreck, Greenhalgh with Thistleton, Elswick, Woodplumpton, Barton and Cockerham; and so much of the parishes of Medlar with Wesham, Treales Roseacre and Wharles, and Clifton with Salwick as lies to the north of the railway from Preston to Fleetwood (Preston and Wyre Line).
