## LONDON TRAFFIC ACT, 1924.

## SECTION 7.

Notice is hereby given that the Minister of Transport by virtue and in exercise of the powers given to him by Section 7 of the London Traffic Act, 1924, and the Regulations from time to time made by him thereunder, after consulting the London and Home Counties Traffic Advisory Committee, has relaxed the restrictions and limitations imposed by the said Regulations upon the occasion of the Motor Cycle Races to be held at the Stadium, Wembley, on Friday the 21st day of August, 1931, so that nothing in the said Regulations shall:—

(b) prevent any person who is maintaining at the date of this Notice a regular service in accordance with Section 6 of the London Traffic Act, 1924, on week-days, upon the approved route numbered 218E from using on Friday the 21st day of August, 1931, between the hours of 7 p.m. and 11 p.m. for the purpose of plying for hire upon that route in any of the streets or parts thereof declared to be "restricted streets" by any Order
