## MINISTRY OF HEALTH.

## LOCAL GOVERNMENT ACT, 1929.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Health, after the expiration of at least 40 days from this date, an exercise of the powers conferred upon him by paragraph (b) of subsection (1) of Section 108 of the Local Government Act, 1929, to make Regulations entitled the Local Government (Adjustments of Grants) Regulations.

And that on account of urgency the Minister of Health, under Section 2 of the Rules Pub-
