

CANCELLATION OF A STANDING FOR HACKNEY CARRIAGES.

By virtue of the Act 13 and 14 Victoria, chapter 7, intituled "An Act for Consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of Commissioners of Police of the Metropolis, and making other provisions in regard to the Consolidated Offices."

I, the undersigned, Commissioner of Police of the Metropolis, do hereby CANCEL the appointment of the following Standing for Hackney Carriages at the following place:—

1st September, 1931.

CANCELLATION.

AT RUSSELL SQUARE, W.C. ...

In three portions.

Thirty Hackney Carriages:

First Portion.—Ten carriages on the North side of Russell Square, commencing at the North-east corner, at a point opposite No. 11, and extending Westward, by kerb around the garden enclosure, as far as necessary for ten carriages.

Front of vehicles toward the East.

Second Portion.—Ten carriages on the North side of Russell Square, commencing at a point in line with the Western building line of Upper Bedford Place, and extending Westward, by kerb around the garden enclosure, as far as necessary for ten carriages.

Front of vehicles toward the East.

Third Portion.—Ten carriages on the West side of Russell Square, commencing at a point opposite No. 35, and extending Southward, by kerb around the garden enclosure, as far as necessary for ten carriages.

Front of vehicles toward the North.

The first portion of the Standing to be fed exclusively by carriages from the second portion, and the second portion by carriages from the third portion.

AT SOUTH PARK ROAD,

Five Hackney Carriages:

On the North side of roadway, commencing at a point ten yards East of the Eastern kerb line of Queen's Road, and extending Eastward, by kerb, as far as necessary for five carriages.

Front of vehicles toward the West.
