

or part of the ground annexed or belonging thereto (not being ground forming part of a churchyard which shall have been used for burials) shall be sold and disposed of by us, the said Ecclesiastical Commissioners, at such time or times and in such manner in all respects as we shall deem expedient. Provided always that such sale or disposal shall be subject to the conditions and restrictions imposed by the said Union of Benefices Measure, 1923.

" 2. That the net proceeds to arise from the sale or sales to be made by us, the said Ecclesiastical Commissioners for England, as aforesaid, after the payment thereof of all costs and expenses of or in relation to such sale or sales and to the carrying into effect of this Scheme shall be applied by us, the said Ecclesiastical Commissioners for and towards the cost of the provision of a Parish Hall for the said New Parish of Saint Andrew, West Bromwich.

" 3. That the font, communion table, sacramental plate, bells and other furniture and fittings of the Old Church or such of them as the Bishop of Lichfield shall select shall be transferred to the Parish Church of the said New Parish of Saint Andrew, West Bromwich, and any articles not so transferred shall be appropriated by the Bishop of Lichfield for use in any other Church or Chapel, Churches or Chapels within the said Diocese of Lichfield which the Bishop may select, provided always that any articles that shall not be so transferred or appropriated except the font, communion table and sacramental plate, may be sold and the proceeds shall be added to the fund arising from the sale of the site and materials of the said Old Church as aforesaid.

" Provided always that this Scheme shall not take effect until the consents and approval which by the said Union of Benefices Measure, 1923, are made requisite to the sale under the powers conferred by that Measure of the site of any Church shall be obtained to the sale hereby proposed of the said Old Church and of the site thereof, together with any ground annexed or belonging thereto.

" And provided also that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Union of Benefices Measure, 1923, or of any other Measure of the National Assembly of the Church of England or Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of

the Bishop of Lichfield has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been laid before both Houses of Parliament for the space of two calendar months:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council is pleased hereby to affirm the said Scheme and to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Lichfield.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 30th day of July, 1931, in the words and figures following, that is to say:—

" We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Churches and Cure (hereinafter called 'the said Benefice') of Tudeley with Capel, in the County of Kent, and in the Diocese of Rochester:

" Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Tudeley with Capel is vested in the Right Honourable Evelyn Hugh John, Viscount Falmouth, as tenant for life free from incumbrances and the said Evelyn Hugh John, Viscount Falmouth, is therefore the Patron or person entitled to present or nominate to the said Benefice in case the same were now vacant:
