LAND DRAINAGE ACT, 1930.

Old Haven (Pevensey) and Bulverhythe Streams Catchment Area.

The Minister of Agriculture and Fisheries hereby gives notice that the Old Haven (Pevensey) and Bulverhythe Streams Catchment Board have made application under sub-section (3) of Section 5 of the Land Drainage Act, 1930, that the approved map of the Catchment Area be varied so far as relates to the extent of the main river.

A copy of the approved map on which the proposed variations are shown in green and

purple colour, may be inspected at the offices of the Clerk of the Catchment Board, R. W. Fovargue, Esq., Battle, Sussex, or at the offices of the Ministry. Any objection to the proposed variations of the approved map shall be made in writing and sent by post, addressed to the Secretary, Ministry of Agriculture and Fisheries, at the address mentioned below, so as to reach that office within fourteen days from the date of this notice.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 20TH OCTOBER, 1931.)

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1931 (No. 55).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Further Contraction of the Huntingdon Foot-and-Mouth Disease Infected Area.

1.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 52) as amended by the Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 54) shall be read and have effect as if the Area described in the First Schedule to this Order were substituted for the Infected Area described in the Schedule to the Foot-and-Mouth Disease (Infected Areas) Order of 1931 (No. 54).

(2) This Article shall come into operation on the twenty-sixth day of October, nineteen hundred and thirty-one.

Release of Infected Area from Restrictions.

2. The Area described in the First Schedule to this Order shall cease to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925 on the second day of November, nineteen hundred and thirty-one, on which day this Order and the Orders described in the Second Schedule to this Order shall be and are hereby revoked.

Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1931 (No. 55).

FIRST SCHEDULE.

Contracted Infected Area.

An Area Comprising:—

In the county of Huntingdon.

The parish of Grafham; and so much of the parishes of Ellington, Easton, Spaldwick, Stow, Kimbolton, and Great Staughton as lies within the following boundary, namely:—

Commencing at a point east of Ellington village where the main Huntingdon—Thrapston road crosses the Ellington parish boundary, thence in a westerly direction along that road via Ellington village as far as Spaldwick village, and the road to Stonely; thence in a generally southerly direction along the latter road via Long Stow village and Bigram's Lane to Stonely; thence south-easterly along the road from Stonely via Agden Green, Dillington Farm and Dirty Lane to the point where the last-mentioned lane meets the Great Staughton—Midloe parish boundary; thence in a generally northerly direction along that parish boundary and the eastern boundaries of the parishes of Grafham and Ellington to the point of commencement.
