

2. Lancaster to Heysham Towers.

Commencing at Scotforth, Lancaster, and proceeding thence via Road A.6, Chapel Street, Cable Street, Road A.6, Owen Road, Road A.589, Road B.5321, Road B.5274, Road A.589 and Middleton Lane to Heysham Towers.

3. Lancaster to Morecambe and Heysham.

Commencing at Dalton Square, Lancaster, and proceeding thence via Road A.6, Chapel Street, Cable Street, Road A.6, Owen Road, Road A.589, Road B.5321, Station Road to Poulton Hall, Morecambe and Heysham.

4. Lancaster to Hest Bank.

Commencing at Damside Street, Lancaster, and proceeding thence via Cable Street, Road A.6, Hest Bank Lane, to Railway Station, Hest Bank.

5. Lancaster to Bolton-le-Sands.

Commencing at Damside Street, Lancaster, and proceeding thence via Cable Street, Road A.6, to Royal Hotel, Bolton-le-Sands.

6. Lancaster to Halton.

Commencing at Damside Street, Lancaster, and proceeding thence via Cable Street, Road A.6, Halton Road to Greyhound Hotel, Halton.

7. Lancaster to Caton and Brookhouse.

Commencing at Damside Street, Lancaster, and proceeding thence via Cable Street, Road A.6, Road A.683 to Caton and along Brookhouse Road to the Black Bull Hotel, Brookhouse.

8. Lancaster to Conder Green.

Commencing at Dalton Square, Lancaster, and proceeding thence via Road A.6, Penny Street Bridge, Road A.588 to Conder Green.

9. Lancaster to Aldcliffe.

Commencing at Dalton Square, Lancaster, and proceeding thence via Road A.6, Brock Street, Common Garden Street, King Street, Queen Street, Lindow Hill, Lindow Square, Regent Street, South Regent Street, Aldcliffe Road to Aldcliffe Village.

10. Lancaster to Galgate.

Commencing at Dalton Square, Lancaster, and proceeding thence via Road A.6 to Cross Roads at Galgate Village.

And notice is hereby further given that objection to the giving of such consent may be sent in writing to the Traffic Commissioners (North Western Area), 9, Gore Street, Piccadilly, Manchester, on or before the 1st day of December, 1931, by any other Local Authority, by the County Council of the County, or by persons who are already providing transport facilities on or in the neighbourhood of any part of any routes to which the several applications relate.
