

theless any person or persons (if any) possessing a legal right by faculty or otherwise to any pew or sitting in any or either of the said Parish Churches and who may not be willing to relinquish and give up the same.

"That the inhabitants of the aforesaid portions so to be separated shall have such and the same right to have marriages baptisms churchings and burials solemnized and performed in the respective Parish Churches of the Parishes to which the portions are to be so annexed as they might have had in the Parish Churches of the Parishes from which such portions were separated.

"That all fees ecclesiastical offerings and emoluments (but excluding Tithes if any) arising from the said portions so to be separated shall henceforth belong to the respective Incumbents of the Benefices to which such portions are respectively annexed.

"That no alteration shall be made in the endowments of the said Benefices or any of them.

"That no alteration shall be made in the Patronage of the said Benefices or any of them.
